## STREAMINED GRANDROCESS For 2024

The addition of the Shaping Tomorrow Awards present us with an opportunity to streamline grantmaking in 2024. Please be sure to keep the following changes in mind as your organization considers its grant application strategy:

 Dollars from the Lancaster Environmental Fund, the Sam & Verda Taylor Fund (Performing Arts), and Florence Starr Taylor, Lancaster Arts & Culture, and Eloise Aurand Funds (Visual Arts) will supplement the Shaping Tomorrow Awards, meaning we will be awarding MORE than \$1,000,000 through this program! Applicants who normally seek funding through these Passion Grants are encouraged to submit their applications through the Shaping Tomorrow Awards process.

Dollars from the Katherine K. Gaeth
Fund, which focuses on housing, will now
supplement the grants offered by the Lancaster
County Homelessness Coalition through
its Homelessness Services Grants that will
distribute a total of \$1,590,000 throughout

We will continue to support previous cohorts throughout 2024, but we will not offer new grants through these programs this year.



# To celebrate 100 years of collective impact, we want to catalyze ideas that will inspire our community to CHANGE THE NEXT 100.

Through the Shaping Tomorrow Awards, more than \$1 Million of additional funds will be invested into Lancaster County. Whether your ideas are big dreams or small steps, we want to support the very best projects that focus on four future-focused categories:

**Because the Shaping Tomorrow awards** were announced in September 2023, the deadline to apply for Quarter 1 awards - Creative Expression and Well-Being & Vibrancy - has now passed.

The deadline to apply for Quarter 3 awards - Next Generation and Our Planet - is July 22, 2024.

#### Up to \$100,000

Recognizing the arts contribute to healthy communities and local economies, we also know talented folks can educate, inspire, and bring about lasting change. We will support projects related to visual arts, performing arts, music, dance, poetry, spoken word, and/or film that promote diverse voices, cultural understanding, community murals, and artistic innovation.

How might we put Lancaster County on the map as a place where people are physically, mentally, and financially healthy? We will support projects focused on mental health, healthcare access, nutrition, physical activity, elder care, and/or financial health.

We need to elevate and invest in the next generation of children and young adults by providing them with opportunities to lead. We are excited to support projects in education, skills development, and/or leadership development. Specific examples could include mentorship programs, scholarships, and/or social entrepreneurship training.

#### **OUR PLANET**

#### Up to \$100,000

We know Lancaster County faces many unique environmental challenges simultaneously: our air quality is poor, our waterways are notorious for polluting the Chesapeake Bay, our tree cover is sparse, we need to save the bits of natural land that remain, and the unpredictability of our future climate threatens our agriculture. We are looking for the best ideas focused on things like land conservation, renewable energy, adaptation to climate change, biodiversity, and/or environmental education.

## How does an organizational endowment work?

Endowments are a tool to provide consistent, longterm funding for your organization. Assets (cash, stocks, real estate, and more) that are donated to your organization through the Community Foundation are pooled and invested. Once a year, 4% of the total is available to spend or be reinvested. The spendable amount is unrestricted—it can be spent in whatever way serves your organization best.

#### What are the benefits?

When you're connected with us through endowment, you're in good company with more than 70 other community benefit organizations in the county.

Having an organizational endowment with the Community Foundation is a way to outsource endowment as a part of your overarching fundraising strategy. We take care of donor acknowledgments, oversight of investments through PNC, a dedicated webpage for online giving (no transaction fees), fundholder events, and further learning opportunities.

All organizations with an endowment of \$50,000 or more are also able to open a Flex Fund, which allows for access to the full amount in that fund at any time for discretionary use.

#### Who is eligible?

Any 501(c)(3) organization is eligible to open an endowment at the Lancaster County Community Foundation. However, this won't be the best fit for every organization. Things to consider include financial stability, an established donor base, a mission that you want to extend into the future, and board commitment. We do not have a minimum contribution to establish a fund, and distributions will be made once the fund reaches \$10,000.



## What are other options besides endowment for CBOs?

If endowment isn't the right fit for you right now, there are a range of other options available. Board members and individual donors can open funds at the Community Foundation to benefit your organization, again with ease of administration by us.

#### UPCOMING ENDOWMENT TRAINING

Current organizational fundholders with us are invited to a new endowment training, being held in July. Stay tuned for details!

#### **Donor Advised Funds**

When a donor or board member opens a Donor Advised Fund at the Community Foundation, they can use it to grant money to your organization and others throughout the year. A Donor Advised Fund is one of the most flexible giving options available at the Community Foundation.

#### **Charitable Gift Annuity**

A planned giving vehicle that allows the donor to receive a fixed income stream for life while making a significant contribution to organizations of their choice. At the Community Foundation, charitable gift annuities convert to an endowed fund for your organizations after the donor passes away.

#### **Legacy Giving**

Planned gifts are an opportunity for people from all income levels to leave a lasting impact. There is no outof-pocket cost and this can be done in a variety of ways.
